7.1.1 Request for Amendment of the Regional Community Investment Fund Policy (ADM-026)

Whereas By-law 2024-08 to adopt a *Regional Community Investment Fund Policy* (ADM-026) was passed by Council on February 28, 2024.

Be it resolved that the *Regional Community Investment Fund Policy* be amended as follows: in cases where a proposed project, where all funding is retained by the lower-tier municipality, is supported by

a resolution of a lower-tier municipal Council and where no funding is to be donated to third parties, a formal funding agreement with the United Counties of Prescott and Russell will not be required. A resolution from the lower-tier municipal Council detailing how the funds will be utilized and how the United Counties of Prescott and Russell's contributions will be publicly recognized and advertised will suffice. This public recognition and advertisement will be preapproved by the United Counties of Prescott and Russell.

Be it further resolved that the *Regional Community Investment Fund Policy* be further amended as follows: any such project may be preapproved for multi-year funding, without extending beyond the current Term of the United Counties of Prescott and Russell Council, subject to the availability of funds from the United Counties of Prescott and Russell as determined by the annual budget.

Be it further resolved that the *Regional Community Investment Fund Policy* be further amended as follows: in cases when a formal funding agreement with the United Counties of Prescott and Russell is not required, an insurance certificate and the mandatory reporting, as mentioned in subsection 5.11 of the *Regional Community Investment Fund Policy*, will also not be required.
